***Please note we do not charge by the hour, we charge by the program.**

We certify that their return of unearned TA funds policy for this institution is compliant with the above DoD requirement. And in those instances when a Service member stops attending due to military service obligation, the educational institution will work with the affected Service member to identify solutions that will not result in a student debt for the returned portion. In addition, we will return any TA funds directly to the Military Service, not the Service member.

Our institution's policy on the schedule for returning unearned TA funds to the government is to complete a scheduled hours return of funds calculation. Once that is complete, any unearned tuition will be returned directly to the Military Service, not the Service member. If all the funds are owed, no return will be sent. If funds are due the school, a bill will be sent to the Service member. See below for two examples of the schedule for return of unearned TA funds: a pro-rata calculation of completed hours divided by class scheduled hours. Once 61% of the class scheduled hours have transpired, 100% of the tuition is due.

Example program 820 Clock Hours:

- 0 scheduled hours = 100% return of TA funds
- 205 scheduled hours = 75% return
- 410 scheduled hours = 50% return
- 493 scheduled hours = 0% return (this is over 60% scheduled hours)

Example program 774 Clock Hours:

- 0 scheduled hours = 100% return of TA funds
- 193.5 scheduled hours = 75% return
- 387 scheduled hours = 50% return
- 465 scheduled hours = 0% return (this is over 60% scheduled hours)

Required supplies lists will be issued for each course prior to enrollment. These lists include all of the kit, book, manual and uniform items that will need to be purchased. The books, manual, uniform and many kit items are not available for purchase elsewhere. Any kit items not purchased through Phagans' Cosmetology Colleges must be equivalent to the one(s) available for purchase through Phagans' Cosmetology Colleges.

The student Enrollment Agreement includes charges for tuition and the enrollment fee, if applicable (*App = application fee of \$50 which is non-refundable and due with your admissions packet; Efee = enrollment fee of \$100). Separate Purchase Agreements include the charges for kits, books, manual, and uniform charges if applicable. Tuition cost for over normal contract time is \$10.00 per hour.

Students are charged for the tuition cost of the academic year in which they are currently enrolled and for the required supplies as they are received. Federal Title IV Financial Aid is available, for most programs, to those who qualify. Please see the Financial Aid Advisor for further information. (We accept monetary forms of payment except cash)
